

Pursuant to Article 101, paragraph (2), item (6), Article 146c and Article 162, paragraph (1) of the Credit Institutions Act (Official Gazette 159/2013, 19/2015, 102/2015, 15/2018, 70/2019, 47/2020, 146/2020 and 151/2022) and Article 43, paragraph (2), item (10) and Article 86, paragraph (3) of the Act on the Croatian National Bank (Official Gazette 75/2008, 54/2013 and 47/2020), the Governor of the Croatian National Bank hereby issues the

**Decision on amendments to the  
Decision on statistical and supervisory reporting**

**Article 1**

In the Decision on statistical and supervisory reporting (Official Gazette 85/2018, 47/2019, 14/2020, 53/2020, 122/2020, 53/2021, 142/2021 and 108/2022), in Article 3, paragraph (2) is amended to read:

"(2) Credit institutions shall submit to the Croatian National Bank all of the reports referred to in Article 4 of this Decision. Branches of foreign banks and the Croatian Bank for Reconstruction and Development shall submit to the Croatian National Bank only the reports collected for statistical purposes, as provided for in Article 4, paragraph (2) of this Decision, and only the reports on an unconsolidated basis."

**Article 2**

In Article 4, paragraph (1), item (20) is deleted.

Paragraph (2) is amended to read:

"(2) The reports referred to in paragraph (1), items (1), (2), (4) to (7) and (11) to (16) of this Article shall be submitted for statistical purposes. The reports referred to in paragraph (1), items (1), (3) to (6), (10), (12), (13), (14), (16) and (17) shall be submitted for supervisory purposes."

In paragraph (3), item (6), the words "(8) to (12) and (16) to (19)" are replaced by the words "(10) to (12), (16) and (17)".

At the end of item (6), a full stop is added.

Item (7) is deleted.

In paragraph (4), the words "(8) to (13) and (16) to (19)" are replaced by the words "(10) to (13), (16) and (17)".

Paragraph (6) is amended to read:

"((6) The report referred to in paragraph (1), item (12) of this Article shall include data to be submitted in different types of reports so this requirement shall be specified in more detail in the Instructions for statistical and supervisory reporting."

**Article 3**

In Article 5, paragraph (1), item (6) is deleted.

At the end of item (10), the word "and" is deleted.

Item (11) is deleted.

#### **Articles 4 to 13**

*These Articles list technical specifications for the preparation and submission of statistical and supervisory reports and are therefore not included in the translation.*

#### **Article 14**

The last report "Economic support measures in response to the COVID-19 pandemic" in accordance with the Decision on statistical and supervisory reporting (Official Gazette 85/2018, 47/2019, 14/2020, 53/2020, 122/2020, 53/2021, 142/2021 and 108/2022) shall be the one which credit institutions submitted to the Croatian National Bank with the balance as at as 31 December 2022.

#### **Article 15**

This Decision shall enter into force on the eighth day after the day of its publication in the Official Gazette, with the exception of Article 7, which shall enter into force on 31 March 2023 and Articles 8 and 9, which shall enter into force on 30 April 2023.
