






Graphical representation of the value of card payment transactions per capita in EUR – total in 2017













Graphical representation of the total number of ATMs and EFTPOS terminals as at 31 December 2017



Graphical representation of the number of ATMs and EFTPOS terminals per million inhabitants relative to the EU average – as at 31 December 2017







Graphical representation of the number of cash withdrawal transactions at ATMs in the country in 2017 – total in millions







Graphical representation of the value of cash withdrawal transactions at ATMs in the country – total in 2017 (EUR billions)





Value of cash withdrawal transactions at ATMs per payment card issued in the country – total in 2017 in EUR










Graphical representation of the value of payment transactions at EFTPOS terminals in the country – total in 2017 (EUR billions)






