

Pursuant to Article 116, paragraph (4) of Regulation (EU) No 575/2013 of the European Parliament and of the Council of 26 June 2013 on prudential requirements for credit institutions and investment firms and amending Regulation (EU) No 648/2012 (OJ L 176/2013) (Text with EEA relevance) (OJ L 176, 27. 6. 2013 and L 208, 2. 8. 2013 and L 321, 30.11.2013), and Article 11, paragraph (1) of the Credit Institutions Act (Official Gazette 159/2013, 19/2015 and 102/2015), and Article 43, paragraph (2) item (9) of the Act on the Croatian National Bank (Official Gazette 75/2008 and 54/2013), the Governor of the Croatian National Bank hereby issues the

Decision

on amendments to the Decision implementing the part of Regulation (EU) No 575/2013 pertaining to the valuation of assets and off-balance sheet items and the calculation of own funds and capital requirements

Article 1

In the Decision implementing the part of Regulation (EU) No 575/2013 pertaining to the valuation of assets and off-balance sheet items and the calculation of own funds and capital requirements (Official Gazette 160/2013 and 140/2015), in Article 2, paragraph (1), at the end of item (11), the full stop is deleted and after item (11), item (12) is added which reads:

"12) public sector entity" as determined by Article 4, paragraph (1), item (8) of Regulation (EU) No 575/2013".

In paragraph (2), item (2) is amended to read:

"2) "central government in the Republic of Croatia" means state authority bodies financed from the budget of the Republic of Croatia, in particular:

- legislative authorities: the Office of the President of the Republic of Croatia and the Croatian Parliament,
- executive authorities: the Government of the Republic of Croatia, ministries of the Republic of Croatia, central state offices, state administration organisations and state administration offices in counties,
- judicial and justice authorities: minor offence courts, High Court of Minor Offences, administrative courts, High Administrative Court, commercial courts, High Commercial Court, municipal courts, Municipal Civil Court in Zagreb, Municipal Criminal Court in Zagreb, Municipal Labour Court in Zagreb, county courts, Supreme Court, Constitutional Court, municipal state attorney's office, county state attorney's office, State Attorney's Office of the Republic of Croatia, State Attorney's Office – Office for the Prevention of Corruption and Organized Crime, Ombudsman for Children, Disability Ombudswoman, Gender Equality Ombudsperson, Ombudsman, State Judicial Council, State's Attorney Council,

Office for General Affairs of the Croatian Parliament and of the Government of the Republic of Croatia.".

Article 2

Article 13 is amended to read:

"A credit institution shall apply Article 116 of Regulation (EU) No 575/2013 in such a way as to weight the exposures to below listed public sector entities in the Republic of Croatia as exposures to the central government:

15. Hrvatska radiotelevizija
